TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this “Win Lunch for a Month” Promotion (**Promotion**) is deemed acceptance of these Terms and Conditions.
2. The Promoter is Adelaide Central Plaza Pty Ltd ACN 000 229 381 care of Centre Management, Adelaide Central Plaza shopping centre, 100 Rundle Mall, Adelaide SA 5000 (**Promoter**).

ELIGIBILITY

3. Entry is only open to **residents of Australia**.
4. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this Promotion.
5. 6. Promotion commences at **7.30am ACDT on Friday 12 September 2025** and ends at **6.00pm ACDT on Monday 6 October 2025 (Promotion Period)**. All times throughout the Terms and Conditions will be based on Adelaide local time unless otherwise advised.

HOW TO ENTER

7. To enter, eligible individuals must, during the Promotion Period, scan the QR Code in Centre or **visit adelaidecentralplaza.com.au** and follow the prompts to the promotion entry page, fully and correctly complete their entry in accordance with the instructions provided, and submit the fully completed entry form.

LIMITS ON ENTRY

8. Entry is limited to one entry, per email address.

DRAW DETAILS

9. The draw will take place at Adelaide Central Plaza, 100 Rundle Mall Adelaide SA 5000, at **10.30am ACDT on Tuesday 6 October 2025**.
10. The Promoter reserves the right to draw additional reserve entries in case of an invalid entry or invalid entrant.
11. The provisional winners will be notified by telephone and in writing within two (2) business days of the draw. A provisional winner will only be deemed the winner once verified by the Promoter.
12. The winners’ names will be published on the Promoter’s website from 7 October for 7 days.

The Promoter reserves the right to request a provisional winner provide proof of identity, proof of residency, and/or proof of entry validity.
